

**Ultimate Companion, LLC**  
**Dog Training & Boarding Waiver**

1. I have read, fully understand, and agree to comply with Ultimate Companion, LLC's policies.
2. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are with Ultimate Companion, LLC.
3. I acknowledge that Ultimate Companion, LLC has relied upon my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.
4. I acknowledge that due to the way dogs interact with one another, minor cuts and scratches can occur even though the dogs are supervised.
5. While my dog(s) is/are in the care and custody of Ultimate Companion, LLC, I hereby authorize Ultimate Companion, LLC, its agents, and/or representatives to seek immediate veterinary care for my dog(s). I understand that all costs in connection with, veterinary, medical or other treatment shall be my sole responsibility.
6. I acknowledge that while my dog is staying with Ultimate Companion, they will be in proximity with, or exposed to other dogs. I acknowledge and agree that in the unlikely event that my dog is injured by another dog, I will not hold Ultimate Companion responsible for the injury. If my dog injures another dog, I will be solely responsible for any injury that occurs, whether to your dog or another.
7. All dogs staying at Ultimate Companion are required to be fully vaccinated. However, it is still possible for a dog to become ill, even when vaccinated, especially when stressed by being away from home. This is not due to any circumstances or conditions at our facility, and you agree that you will not hold us liable in the event your dog becomes ill during or after its stay.
8. I acknowledge that Ultimate Companion cannot be held liable for dog's wellbeing in situations where dog is old or in questionable health because of the stress that can occur simply from being away from home.
9. Ultimate Companion, LLC reserves the right to refuse admittance of any dog or dismiss any dog that does not meet or maintain the health, temperament or other standards. The determination shall be made at the sole discretion of Ultimate Companion, LLC.
10. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Ultimate Companion from any and all claims, demands, or causes of action, which are in any way connected with Ultimate Companion's services, including any such claims which allege negligent acts or omissions of Ultimate Companion.
11. Should Ultimate Companion, LLC or anyone acting on their behalf, be required to incur lawyer's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
12. In the event that I file a lawsuit against Ultimate Companion, LLC, I agree to do so solely in the state of South Dakota, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
